

## Agreement for inclusion on HawaiiKineMarket.com

BETWEEN: Hawaii Kine Market (HawaiiKineMarket.com) (the "Service Provider", "HKM"), a website operating in the State of Hawai'i  
AND \_\_\_\_\_ (the "vendor") a business or entity that is legally authorized to operate in the State of Hawai'i

The parties agree as follows.

1. The Vendor agreement includes store setup and consultation. HKM will make the tools available to you to manage your own store, view customer messages, update store info and view orders.
2. A business info/bio page (up to 1200 words) is included in your setup cost. Vendor is responsible for keeping all information up to date either through Vendors CMS or by sending an email to admin@hawaiiinmarket.com.
3. You agree that **20% of net sales of original work** and **60% of net sales of glicees, prints and promotional items created for you by HKM** will be remitted to HKM each month.
4. HKM shall pay Vendor each month the according to the following schedule. Monies collected, minus, cost of products and shipping, minus HKM commission will be paid by the 22th of the month. Each subsequent monies due will be paid by the 22th of the next month upon receipt of funds collected by each 15th of the month. A itemized report of sales will be provided with each monthly payment. You may request payment by Paypal, Venmo or check.
5. Vendor has the right to request payment on a different schedule if the need arises. HKM retains the right to refuse the request.
6. HKM reserves the right to use your photographs/videos for marketing purposes, to reproduce images already sold or to create products for sale by the vendor such as prints, tee shirts, tote bags, etc. All other use by HKM or associates is prohibited.
7. Print sizes & prices will be determined by artist.
8. Artist reserves the right to withdraw any images at any time.
9. HKM reserves the right to refuse service, remove or edit content, or cancel orders in that are in violation of local or Federal law, is racist, biased or pornographic.
10. Tech support is available during regular business hours on a first come first served basis. You may also submit a ticket by email to admin@hawaiiinmarket.com at anytime.
- 11 . HKM will supply digital ads, HKM logo, promotional materials, promotional specialty items and other marketing items to vendors.
12. HKM will do advertising and marketing with other media to help promote products and services on HKM. HKM will be open to suggestions from Vendor, although this is not a guarantee it will take place. HKM will not reimburse for Vendor's personal advertising unless prior approval has been granted by the an authorized HKM representative.
13. HKM will issue a 1099 to Vendor. Vendor is responsible for all county, state and federal taxes.
14. HKM may terminate this agreement without cause at any time upon 7 days written notice to the Vendor; and the Vendor may terminate this agreement without cause at any time upon 7 days written notice to HKM. Once termination date has been established all revenue and commissions will be paid through the date of final termination.
